Paul Blustein is an author and journalist specializing in economic issues. He spent much of his career reporting for *The Washington Post* and *The Wall Street Journal*, and he has authored six books focusing mainly on financial crises and global trade. His latest book, published in September 2019, is *Schism: China, America and the Fracturing of the Global Trading System*. Articles he has written in recent years have been published by Fortune, Slate, Politico, Foreign Policy, Bloomberg View, and other media outlets.

Mr. Blustein has degrees from the University of Wisconsin (BA, History), and from Oxford University, where as a Rhodes Scholar he studied Philosophy, Politics and Economics.

Andrea K. Bjorklund is a Full Professor and the L. Yves Fortier Chair in International Arbitration and International Commercial Law, at McGill University Faculty of Law. She acts as arbitrator and expert in both investment and commercial arbitrations and as an expert in court proceedings related to arbitration. She is on the panel of arbitrators of the Beijing Arbitration Commission/Beijing International Arbitration Center, and AAA's International Centre for Dispute Resolution. She is also a U.S. appointee to the NAFTA Chapter 19 (and USMCA Chapter 10) roster of arbitrators.

In addition to serving as an adviser to the American Law Institute's project on restating the U.S. law of international commercial arbitration, she is a member of the Advisory Board of the Investment Treaty Forum of the British Institute for International and Comparative Law. Professor Bjorklund was the inaugural ICSID Scholar-in-Residence from 2014-2015 and was Editor-in-Chief of the Yearbook on International Investment Law and Policy from 2012- to 2015. She is one of the co-general editors of *Arbitration International* and is a general editor of the *Journal of International Dispute Settlement*.

Professor Bjorklund is widely published in investment law and dispute resolution. Before entering the academy she was an attorney-adviser on the NAFTA arbitration team in the Office of the Legal Adviser of the U.S. Department of State, in addition to periods at the U.S. International Trade Commission and in private practice at Miller & Chevalier in Washington, D.C. Professor Bjorklund has a J.D. from Yale Law School, an M.A. in French Studies from New York University, and a B.A. (with High Honors) in History and French from the University of Nebraska.

Joshua Karton is an Associate Professor at Queen's Law, where he has taught since 2009. Professor Karton's research and teaching focus on international dispute resolution (in particular international arbitration), international and comparative contract law, conflict of laws, and sociology of law (especially law and globalization). He has written or edited four books and dozens of articles in his areas of interest, and has held visiting positions at a number of universities, most recently as the Tsai

Wan-tsai Visiting Chair Professor of International Law at the National Taiwan University.

Outside of his academic work, Professor Karton sits as an arbitrator in domestic and international commercial disputes, both *ad hoc* and institutional, and also acts as an expert witness on matters of Canadian and international law. He is a General Editor of *Kluwer Arbitration Practical Insights*, a leading online guide for international arbitration practitioners; the Managing Editor of the *Canadian Journal of Commercial Arbitration*, which he co-founded; a faculty member of the Toronto Commercial Arbitration Society's "Gold Standard" course, the premier professional training program for commercial arbitrators in Canada; and an advisory board member and regular instructor for the Africa Arbitration Academy.

Born and raised in Vancouver, Professor Karton received a BA in International Relations and Humanities from Yale in 2001, a JD from Columbia Law School in 2005, and a PhD in International Law from Cambridge in 2011. He practised in litigation and arbitration in the New York and Hong Kong offices of Cleary Gottlieb Steen & Hamilton LLP before commencing his doctoral studies.

Nicolas Lamp is Associate Professor at the Faculty of Law at Queen's University, where he is also cross-appointed to the School of Policy Studies. He is the Associate Academic Director of the International Law Programs, and from 2016 to 2021 he was the Academic Director. Since 2019, he has also been the Director of the Annual Queen's Institute on Trade Policy, a professional training course for Canadian trade officials that is hosted by the Queen's School of Policy Studies.

Prior to joining Queen's, Professor Lamp worked as a Dispute Settlement Lawyer at the Appellate Body Secretariat of the World Trade Organization, where he advised the Members of the Appellate Body on legal issues arising in appellate proceedings under the WTO's dispute settlement mechanism. In addition to teaching the International Economic Law course in the castle program, he also teaches a term-length course in International Trade Law and supervises the International Trade Law Practicum, a clinical course in trade law.

Professor Lamp received his PhD in Law from the London School of Economics and Political Science in 2013. His doctoral thesis on "Lawmaking in the Multilateral Trading System" investigates the origins and implications of the discourses, practices and techniques that shape international lawmaking in the trade context. His current research focuses on competing narratives about the winners and losers from economic globalization. His co-authored book (with Anthea Roberts) titled *Six Faces of Globalization: Who Wins, Who Loses, and Why It Matters* was published in 2021 by Harvard University Press.

Alison Mitchell is a former diplomat and legal adviser to Canada's foreign ministry. She is specialized in the law of armed conflict, international human rights law, targeted sanctions, and the law of the sea. During her 17 years with Global Affairs Canada, Ms. Mitchell had assignments to Canada's embassy in Washington, D.C., to NATO in Brussels, to UN Headquarters in New York, and to the Provincial Reconstruction Team in Kandahar, Afghanistan. In 2012-2013, she spent a year on exchange with the Canadian Armed Forces in the Office of the Judge Advocate General. She previously served as an assistant legal officer in the Office of the Prosecutor at the International Criminal Court in The Hague in 2005-2006 and clerked for Mr. Justice Marshall Rothstein at the Supreme Court of Canada in 2007.

Ms. Mitchell received a B.A. from Queen's University in 2001, an LL.B. from the University of Ottawa in 2005, and an LL.M. in International Legal Studies from New York University in 2012.

Matthew Secomb is a partner in White & Case's International Arbitration Group in Singapore, and heads the firm's arbitration practice in the Asia-Pacific. Dr. Secomb specializes in international commercial arbitration with a focus on energy-related and construction disputes. He has been involved in arbitrations under most of the major institutional rules as well as in *ad hoc* arbitrations. In addition to his counsel work, Dr. Secomb also acts frequently as arbitrator (mainly ICC and SIAC).

Before moving to Singapore in 2015, Dr. Secomb was based in White & Case's Paris office for nearly ten years. Prior to joining White & Case in 2006, he was counsel to the ICC International Court of Arbitration, where he oversaw thousands of arbitrations, spanning almost all industry sectors and regions. Before moving to France in 2001, he worked at Minter Ellison, a leading Australian law firm.

Dr. Secomb has a B.Com. and an LL.M. from the University of Melbourne, an LL.B. (hons) from Deakin University, and a Doctorat en droit (summa cum laude) from the Université de Fribourg (Switzerland). He is qualified as an *avocat* at the Paris bar, a solicitor-advocate in England & Wales, and a barrister and solicitor in Victoria, Australia.
