### How to Apply to Queen's Faculty of Law

Exchange students must first be nominated by their Exchange Coordinator in their home university. The nominated exchange student will then be contacted directly by Queen's University regarding next steps to complete the application procedure.

### Deadlines

April 1, 2018	Student is nominated by home university (notice of both fall and winter term nominees requested). Partner universities will be notified that the online nomination system is live in early 2018.
April 30, 2018	Exchange student nominated for the fall term or full year completes the application process and submits official transcripts.

September 1, 2018	Student is nominated by home university for winter 2018 exchange (earlier notice is preferred).
September 30, 2018	Exchange students nominated for the winter term completes the application process and submits official transcripts.

## Academic and English Language Requirements

The Juris Doctor (JD) professional degree in law is taught at a level comparable to graduate studies. Canadian students are admitted to this program after completion of an undergraduate university degree. Therefore, incoming exchange students should be academically strong, in the upper-years of their legal studies, with a cumulative average of no less than B, (3.0 on a 4.0 grading scale), especially if they will be facing a change from civil law to common law studies and language barriers.

At Queen's, English is the language of instruction and communication, except for the language departments. Proficiency in English is a prerequisite for admission. Applicants whose native languages do not include English may be required to obtain satisfactory standing in an English Language Proficiency Test as part of the application process, and before final acceptance is granted.

**The Faculty of Law at Queen's University requires the following minimum scores:**

### To set up your Queen's email address

Queen's email is the primary means of communication at Queen's Law.

Student e-mail addresses are automatically activated in the following format, [NetID@queensu.ca](mailto:NetID@queensu.ca). To access your Queen's e-mail go to: <http://office365.queensu.ca> and use your NetID and password to sign in. We also highly recommend students create a [first.lastname@queensu.ca](mailto:first.lastname@queensu.ca) alias for their e-mail by logging into <http://netid.queensu.ca> and going to 'Manage your e-mail options'.

## Visas and Permits

Students planning to study in Canada for one term (less than six months), may study under temporary resident status as a visitor. For any period longer than six months (two terms), a study permit is required. Students from some countries require a temporary resident visa (entry visa) to be eligible to enter Canada. Most people that do not require a visa, require electronic Travel Authorization (eTA) to fly into Canada.

## University Health Insurance Plan (UHIP)

Enrolment in the University Health Insurance Plan (UHIP) is compulsory for all international students registered at Queen's University. International students will be automatically enrolled in the University Health Insurance Plan (UHIP) for each term of their enrollment at Queen's University. The fee for single UHIP coverage will appear on the student fee account prior to the start of each term under the title "International Health Care". Payment of the UHIP premium in full is required to register. UHIP rates for 2018-19 will be announced on June 1, 2018. For reference, please see the [fees for the 2017-18 academic year](#).

For use in Canada, UHIP coverage will begin on August 10 (for September starts) and December 10 (for January starts). Students planning to arrive in Canada before that date are recommended to have adequate emergency medical coverage and travel insurance.

## Housing

Incoming international exchange students live off-campus in nearby privately owned housing, usually within a 15-minute walk to campus. We recommend students come to Kingston at least one week in advance to find adequate accommodation, as furnished housing is in high demand in the fall. It is also recommended that students do not sign a lease or send rent money to a landlord before arriving in Kingston.
