

QUEEN'S UNIVERSITY FACULTY OF LAW APPOINTMENTS

The Faculty of Law at Queen's University invites applications for at least two tenure-stream appointments, to begin July 1, 2019. While the primary focus of this search is for an entry-level tenure-track appointment at the rank of Assistant Professor, a tenured appointment at the rank of Associate Professor may be considered for a truly outstanding candidate. The Faculty welcomes applicants in all areas of legal study. Without limiting the call for applications, the Faculty signals a special interest in receiving applications in the areas of aboriginal and indigenous law, intellectual property law (particularly patent law), private law, labour and employment law, tax law, legal ethics and professionalism, international economic law, land use planning and land transactions, and public and constitutional law.

Save in exceptional circumstances, the successful candidate will have a JD/LLB or equivalent and a doctorate in law or a cognate discipline completed at the start date of the appointment. The main criteria for selection are academic and teaching excellence. The successful candidate will provide evidence of high quality scholarly output that demonstrates potential for independent research leading to peer assessed publications and the securing of external research funding, as well as strong potential for outstanding teaching contributions at both the undergraduate and graduate levels, and an ongoing commitment to academic and pedagogical excellence in support of the Faculty's programs. Candidates must provide evidence of an ability to work collaboratively in an interdisciplinary and student-centred environment. The successful candidate will be required to make substantive contributions through service to the Faculty, the University, and/or the broader community. Salary will be competitive and commensurate with the candidate's qualifications and experience. All positions are subject to final budgetary approval by the University.

Nationally and internationally recognized as a leading law school, Queen's Law has a distinguished record of outstanding teaching and research. Located in historic Kingston, Ontario, Queen's Law has a proud history of a high level of faculty and student engagement. Queen's Law has a curriculum and research profile that includes Canada's largest international law program, operated at the Queen's University Bader International Study Centre at Herstmonceux Castle in the UK. The Faculty leads Canadian law schools in interdisciplinary study opportunities, including programs that combine JD studies with Business, Economics, Public Administration, and Industrial Relations. The Faculty is also home to vibrant LLM and PhD programs that draw students from around the world, leading research groups such as the Centre for Law in the Contemporary Workplace, Feminist Legal Studies Queen's, an interdisciplinary Colloquium in Legal and Political Philosophy, and five clinical programs in Poverty Law, Prison Law, Business Law, Elder Law, and Family Law.

The University invites applications from all qualified individuals. Queen's is committed to employment equity and diversity in the workplace and welcomes applications from women, visible minorities, Aboriginal people, persons with disabilities, and LGBTQ persons. All qualified candidates are encouraged to apply; however, in accordance with Canadian Immigration requirements, Canadian citizens and Permanent Residents of Canada will be given priority.

To comply with Federal laws, the University is obliged to gather statistical information about how many applicants for each job vacancy are Canadian citizens/permanent residents of Canada. Applicants need not identify their country of origin or citizenship, however, all applications must include one of the following statements: "I am a Canadian citizen/permanent resident of Canada"; OR, "I am not a Canadian citizen/permanent resident do not include this information will be deemed incomplete.

A complete application consists of:

- A cover letter (including one of the two statements regarding Canadian citizenship/permanent resident status specified in the previous paragraph);
- A current Curriculum Vitae (including a list of publications);
- Copies of all university transcripts;
- Copies of sample publications;
- A statement of teaching interests and experience, including teaching experience and supervision at both the JD and graduate levels (include course outlines and evaluations if available);
- A statement of current and prospective research interests; and
- Letters from at least three referees sent directly by the referee to the address below.

Applicants should also supply information concerning any interruptions in their academic career. Writing samples will not be returned and incomplete applications will not be considered.

Applicants should submit their files by August 15, 2018 <u>directly</u> to the email address included below. Each application document should be attached as a separate file in PDF or Word. Referees should also submit letters of support directly to the same email address below by August 15, 2018. However, if letters from referees are not available by this date, they should be submitted as soon thereafter as is possible. The Committee may still consider applications after this date.
