

STEP 1

Fill out ONE application form

STEP 2

Upload Supporting Documents

- a) your resume
- b) a SOLUS print out of your law school grades
- c) a specific and separate cover letter for each clinic you are applying to

STEP 3

Finish the application process through "Job Postings" in CSM

Under "Job Postings", subtab "CSM Jobs" find the clinic to which you wish to apply.

- a) click the hyperlinked job title
- b) click "Apply", select the correct documents
- c) click "Submit"

You must complete this step for EACH clinic you are applying to
