### **CLERKSHIPS**

The 2021-2022 Clerkship Tip Sheet under the Document Library of CSM contains contacts of current/recent clerks who are willing to speak about their clerkship experience. The CDO is still collecting information from courts across Canada, and we will be updating and uploading our 2021-2022 Clerkship Overview within CSM.

Please note that the courts in Saskatchewan and Alberta have earlier deadlines (i.e. end of November). Interested students should book a meeting with Mike Molas or Julie Banting for support on those applications.

If you are planning to apply to the Ontario Court of Appeal or the Supreme Court of Canada, you need to book a meeting with Dean Walters. Dean Walters writes

letters of recommendation to both these courts so he will want to chat about your experience and interest in clerking. You should bring a copy of your resume to this meeting. Students are also strongly encouraged to book a meeting with Julie Banting to discuss your application.

### Saskatchewan

### **Ottawa Intellectual Property**

If you are interested in working in Ottawa and have a degree in science or engineering, please review the Ottawa IP Guide in the Document Library of CSM and contact our office to discuss the next steps and to receive support. Ottawa employers are recruiting both 1L and 2L students for this summer. Applications are due to employers on October 15 at 1:00 pm ET.

### **East Coast**

Law firms on the East Coast have begun recruiting 1L and 2L students for articling positions following the students' graduation from Queens Law. Students are provided with the option of accepting a summer student position with the firm, as well. ### **2L SUMMER RECRUITMENT**

Students participating in Calgary, Vancouver, or Toronto recruitment should review the regional recruitment guides in CSM. Students participating in Toronto recruitment should also review the Interview Call Day tip sheet, which includes general information related to Intent to Call Emails (ITCs) and scheduling your interview week. ### **Calgary**

Students who have not yet heard from an employer with whom they 1) conducted an OCI or 2) submitted an application by September 25, can be proactive in their outreach and express a desire to meet with those employers in Calgary. Employers usually meet with students around the Thanksgiving Holiday. Offers of employment begin October 24 at 9 AM MT.

### **Vancouver**

In-Office Interview Week runs Monday, October 21 to Wednesday, October 23. Offers of employment begin October 24 at 8 AM PT.

### **Toronto**

Employers can send Intent to Call emails any time prior to Interview Call Day on October 25; employers will begin calling at 8 AM ET that day to schedule your interviews.

In-Office Interview Week begins at 8:00 a.m. ET on Monday, November 4 and concludes at 3:00 p.m. ET on Wednesday, November 6. Between 3:00 p.m. and 5:00 p.m. on Wednesday, November 6, firms are prohibited from contacting students and students are prohibited from contacting firms. Offers of employment will begin at 5:00 pm ET on Wednesday November 6.
