The personal statement should indicate the student's reason for studying in the joint program and address the student's aptitude, skills and suitability for the program. The personal statement should address the applicant's fluency in written and spoken English as well, if not apparent from a transcript.
- 7. Letter of reference (should be an academic reference if possible)
- 8. Any other supporting material as required in Section III
