	for their study as an exchange student at Fudan Law School.
	If you hold an X1 visa, you will need to apply for residence permit in
	the following 30 days after your entry. If you hold X2 visa and the
	validity of your X2 visa is longer than your study period here, you
	can keep your X2 visa with no need to change it. If you stay in China
	for more than six months, however, you will have to apply for the
	residence permit.
