Resume Labs are available to give your resume or cover letter a quick review by an upper year student trained by the CDO.

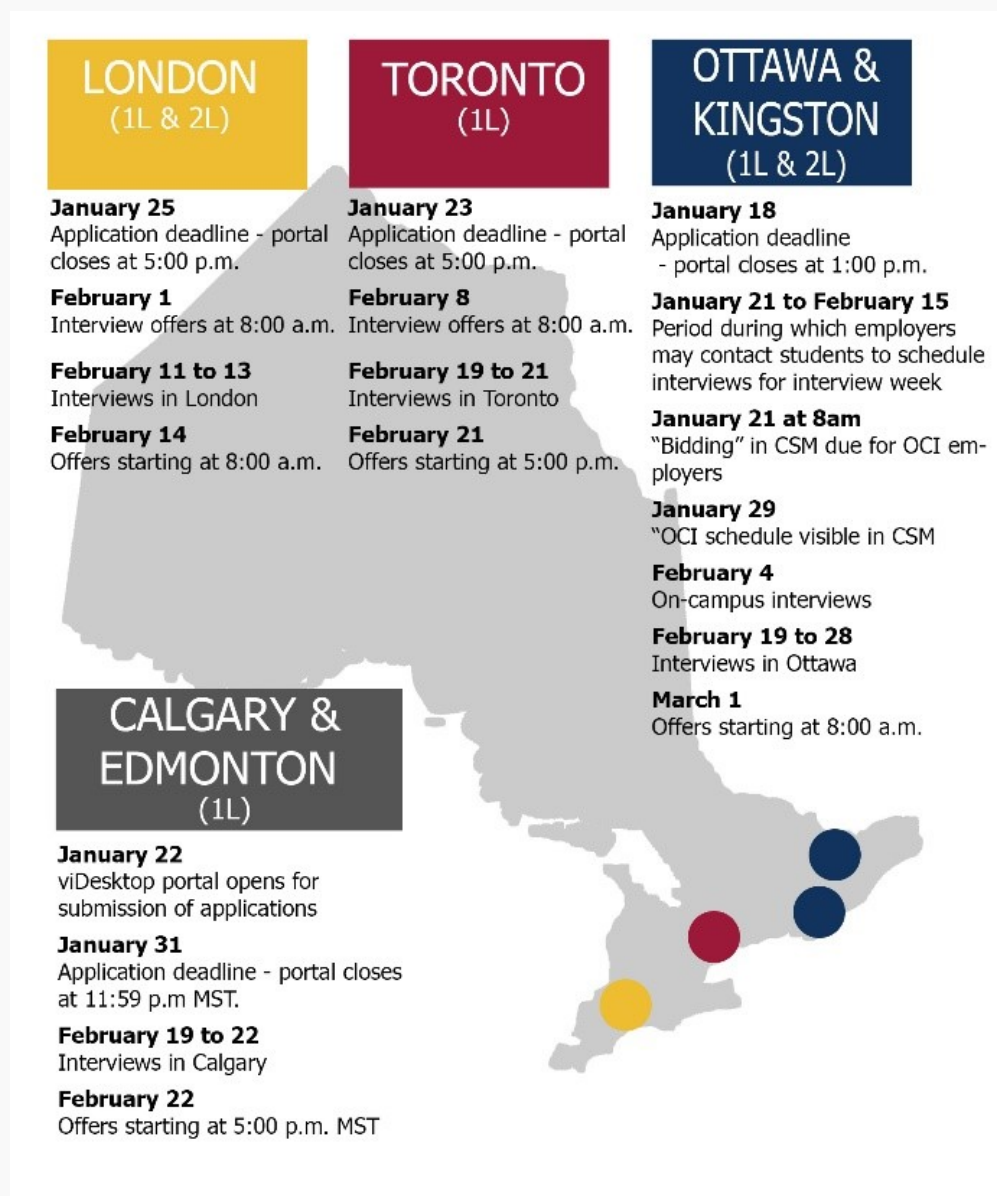
