#### Liberty Lecture: Amy Wax Wednesday, March 6, 2019 - 5:30 pm in Room 202

The Liberty Lecture series explores the law and politics of individual liberty, including freedom of speech and inquiry; the role of autonomy in liberal democracy and Western culture; and the forces that threaten liberty from without and within. Professor Wax is Robert Mundheim Professor of Law at Penn Law. Her work addresses issues in social welfare law and policy, including the relationship between the family, the workplace, and labor markets, group demographics, and the law and neuroscience of deprivation. Her lecture will focus on the destructive effects of the quest for equal results, whose first casualty is truth.
