The *Queen's Law Journal* presents: Contesting Criminal Law: An Event Honoring Professor Don Stuart with Professors Janine Benedet (UBC), Stephen Coughlan (Dalhousie), and Lisa Dufraimont (Osgoode).

This panel event will feature three leading Criminal law and Evidence scholars presenting their forthcoming papers for a special symposium issue of the *Queen's Law Journal* on the legacy of Queen's Law Professor Don Stuart.

Topics include: mandatory minimum sentences in sexual assault and abuse cases; the relevancy of sexual history evidence in relationship cases; and the existence of a *de minimis* defence in criminal law.

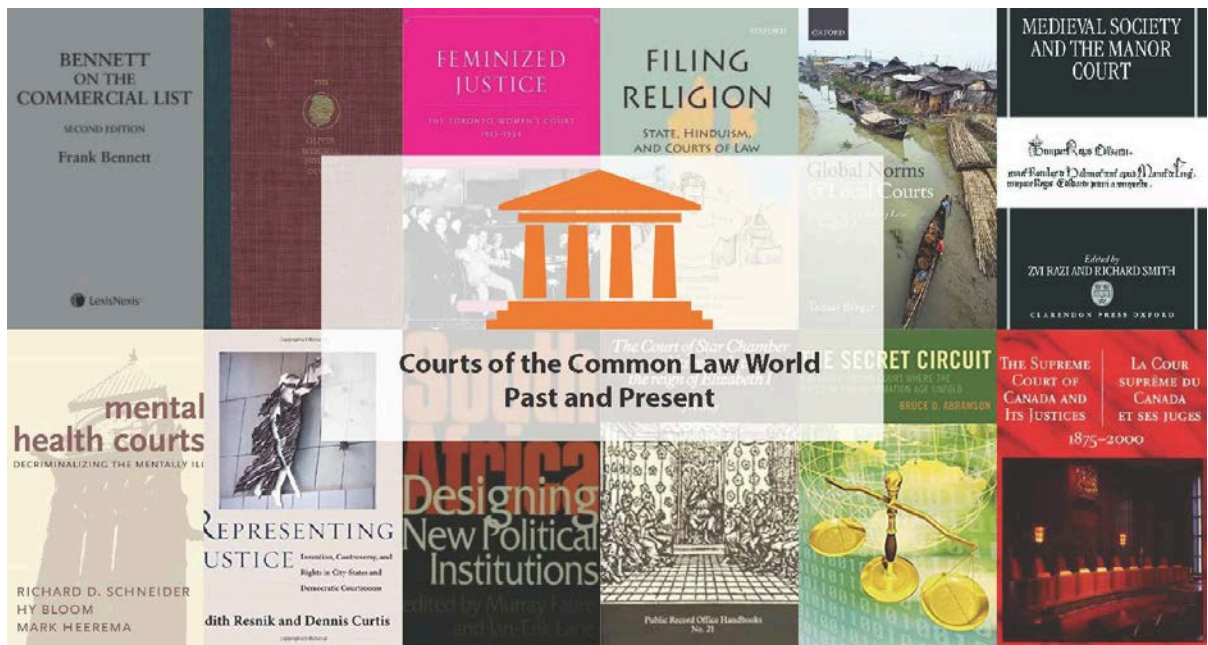
## Participants Needed!
