Introduction

This report lists the scholarly activities and research achievements of the Queen's Faculty of Law in 2010 and 2011. Queen's Law faculty members are engaged at the highest levels of scholarly analysis and debate in Canada and around the world. They continue to provide educational training for Canada's judiciary, to provide advice and opinions to departments of government, and to make submissions to parliamentary committees engaged in law reform. They publish their research in leading journals in Canada and worldwide.

Law faculty members presented their research in 2010 and 2011 at universities and at conferences and public events across Canada, the US and the UK, and also in Australia, Barbados, Bahamas, China, Colombia, Denmark, France, Hong Kong, Italy, Israel, Germany, Hungary, Poland, the Netherlands, Norway, Slovenia, Spain, Switzerland, and Turkey.

In 2010 and 2011, 70 dynamic and high-profile speakers from Canada, the UK, the UK, Australia, Israel and South Africa gave talks at Queen's. Our visitors were academics from the world's leading law schools as well as activists and lawyers from public policy and non-governmental organizations and government offices. The visitors gave named lectures and participated in the visiting speaker series as well as the International Speakers Series; the Law, Economics and Public Policy Workshop; the Osler, Hoskin & Harcourt Distinguished Lectures in Business Law; and Feminist Legal Studies Queen's.

The Faculty's commitment to interdisciplinary and international connections is reflected in our cross-appointments: Professors Will Kymlicka and Michael Pratt with the Department of Philosophy, Professor Richard Chaykowski with the School of Policy Studies, and Professor David Lyon with the Department of Sociology, and the shared, fractional appointment of Professor Les Green with Oxford University.

This report confirms that the Law Faculty continues to enjoy a rich and vibrant research culture in which excellence in legal scholarship is pursued along diverse lines and from diverse perspectives, in accordance with the goals of Queen's Law's *Strategic Plan for Research, 2010-15*.
