<p>Requirements for participation in the Exchange Programme</p>	<p>Students seeking to come to NLU Delhi on a semester exchange must fulfil the following conditions:</p> <ul style="list-style-type: none">✓ Be enrolled in a full-time programme with NLU Delhi's partner institution

		<ul style="list-style-type: none"> ✓ Be officially nominated by their Home University ✓ Have completed at least 2 semesters (one year) of law/allied students at the partner institutions ✓ Have a GPA of 3 out of 7 (or equivalent)
<p>Language of study</p> <p>Language Requirements</p>		<p>All courses at NLU Delhi are taught in English.</p> <p>Students who wish to participate in the exchange programme for Bachelor of Laws (LL.B.) or Master of Laws (LL.M.) courses must have a high level of proficiency in the English language.</p> <p>Proof of English proficiency is required. However, if a student's current University education is conducted in English, formal proof of fluency is not required. A certificate from the student's home institution confirming this will be sufficient.</p> <p>NLU Delhi reserves the right to request such proof or additional documentation from nominated students at its discretion.</p>
<p>Number of places available per term</p>		<p>Two students for one semester each, unless otherwise agreed with the partner institution.</p>
<p>Application procedure</p>		<ol style="list-style-type: none"> 1. An email from the home institution confirming the student's name, year of study, exchange period, GPA, and email address must be sent to internationalrelations@nludelhi.ac.in for nomination to the Exchange Programme at National Law University Delhi. 2. The application form and other relevant information/instructions will be sent by email directly to each selected student after nominations from partner institutions have been received and processed. This information will be communicated only to the student's official university email ID.

		3. In addition to completing the form, students would be required to upload copies of all required documents including a copy of their passport.

Courses offered		Information is emailed to students after their application is processed. All courses selections are done online and students are notified of their enrollments. Students take between 12 & 17 credits per term (usually 4 courses per term). Classes typically run 3-5 hours per week. Introduction meeting /		An orientation meeting is organised for all incoming exchange students. Details will be communicated to nominated students via email.

Orientation Programme	A student buddy is assigned to each international exchange student at NLU Delhi. The buddy, who is a student of NLU Delhi, assists incoming exchange students in settling in and navigating the University and its systems.
Accommodation	<p>Accommodation may be provided in University Students' Halls of Residence, located on the University campus. This is subject to availability. Incoming exchange students must ascertain the availability of accommodation with International Relations Office prior to arrival. A nominal fee will be charged if accommodation is made available.</p> <p>In the event of unavailability, students must make their own arrangements. University does not act as an intermediary in securing accommodation. Queries in this regard may be directed to the International Relations Office.</p>

Insurance	It is mandatory for incoming exchange students to have valid and adequate health/medical insurance in India for the entire duration of their exchange.
