

# Research Assistant Positions

The Faculty of Law, Queen's University, requests applications from suitably qualified JD students interested in a Research Assistant ("RA") position working with Professor Ashwini Vasanthakumar

### **Description:**

Professor Ashwini Vasanthakumar is recruiting a team of Research Assistants to work on transitional justice and diaspora politics. Research Assistants will principally be tasked with compiling literature reviews on (a) philosophical literature on transitional justice; (b) the case study of Sri Lanka and the Tamil diaspora in Toronto; and (c) other case studies that allow the study to be expanded.

The position is ideal for students who are interested in any or all of the following: (a) transitional justice, the politics of memory, and reconciliation; (b) migration and diaspora politics, understood broadly to include migration between states and between nations/regions contained within a state; and (c) particular case studies or contexts of transitional justice and/or diaspora politics.

Professor Vasanthakumar is working towards a project deadline of March 31, 2024. If you have any questions about the work involved, please contact Professor Vasanthakumar at ashwini.vasanthakumar@queensu.ca.

#### **Qualifications:**

JD Candidates will be selected based on interest, availability, and academic merit. Relevant experience with case studies will be an asset.

The work can be done remotely. Research assistants must have access to high-speed internet and a computer that meets minimum requirements. All work can be completed during the regular 9-5 work week, but candidates can work outside of that time frame if they prefer.

Length of contract: 8 - 10 weeks

Hours per week: Approximately 10 hours per week

Hourly Rate for JD students: \$20.00/hour (+4% in lieu of vacation).





## **Application Procedure**
